



## Web Site Privacy Statement

### **Background:**

L B Freight Limited understands that your privacy is important to you and that you care about how your personal data is used and shared online. Any personal data, we do collect will only be used as permitted by law.

### **1. Definitions and Interpretation**

In this Policy, the following terms shall have the following meanings:

**"personal data"** means any and all data that relates to an identifiable person who can be directly or indirectly identified from that data. 4.1.5 The right to restrict (i.e. prevent) the processing of your personal data;

4.1.6 The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation);

4.1.7 The right to object to us using your personal data for particular purposes; and

4.1.8 Rights with respect to automated decision making and profiling.

4.2 If you have any cause for complaint about our use of your personal data, please contact us using the details provided in section 9 and we will do our best to solve the problem for you. If we are unable to help, you also have the right to lodge a complaint with the UK's supervisory authority, the Information Commissioner's Office.

### **5. What Data Do We Collect?**

5.1 Subject to section 5.2, we do not collect any personal data from you. We do not place cookies on your computer or device, nor do we use any other means of data collection.

5.2 If you send us an email, we may collect your name, your email address, and any other information which you choose to give us.

## **6. How Do We Use Your Data?**

6.1 If we do collect any personal data, it will be processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with our obligations and safeguard your rights under the Data Protection Act 1998 **OR** GDPR at all times. For more details on security see section 7, below.

6.2 As noted above, we do not generally collect any personal data. If you contact us and we obtain your personal details from your email, we may use them as follows:

6.2.1 To reply to your email, either by email, telephone or post.

6.3 Any and all emails containing your personal data will be deleted no later than 24 months after contact, unless we have consent to keep the data until it is requested to be deleted.

6.4 You have the right to withdraw your consent to us using your personal data at any time, and to request that we delete it.

6.5 We will not share any of your data with any third parties for any purposes.

## **7. How and Where Do We Store Your Data?**

7.1 We only keep your personal data for as long as we need to in order to use it as described above in section 6, and/or for as long as we have your permission to keep it.

7.2 Your data will only be stored in the UK, on secured server at the company's premises.

7.3 Data security is very important to us, and to protect your data we have taken suitable measures to safeguard and secure any data we hold about you (even if it is only your email address).

7.4 Steps we take to secure and protect your data include:

7.4.1 Backup are taken daily

7.4.2 Data is reviewed annually

7.4.3 The business is password driven and two way encryption

7.4.4 The software packages used are of a recognised companies i.e. Microsoft
